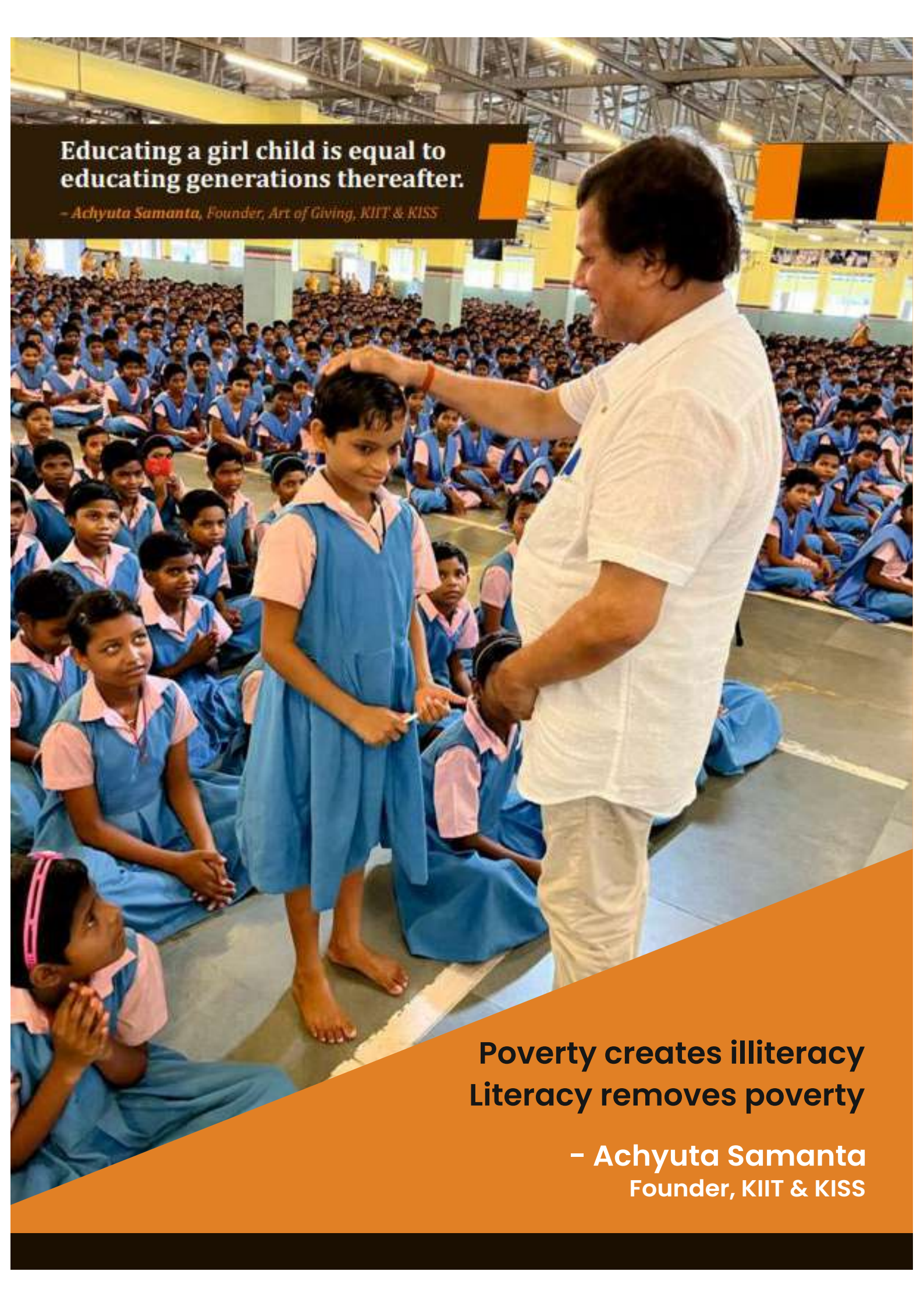

A major obstacle is the severe shortage of healthcare professionals, including doctors, nurses, and paramedical staff. This shortage particularly impacts healthcare delivery in rural areas, where access to trained personnel is limited.

AIMS & OBJECTIVES

AIMS

The aims of the undergraduate program are to

2. Prepare them to assume responsibilities as professional, competent nurses and midwives in providing promotive, preventive, curative, and rehabilitative healthcare services in any healthcare setting.
3. Prepare nurses and midwives who can make independent decisions in nursing situations within the scope of practice, protect the rights of individuals and groups, and conduct research in the areas of nursing practice and apply evidence-based practice.
4. Prepare them to assume the role of practitioner, teacher, supervisor, and manager in all healthcare settings.

OBJECTIVES

On completion of the B.Sc. Nursing program, the B.Sc. nursing graduates will be able to:

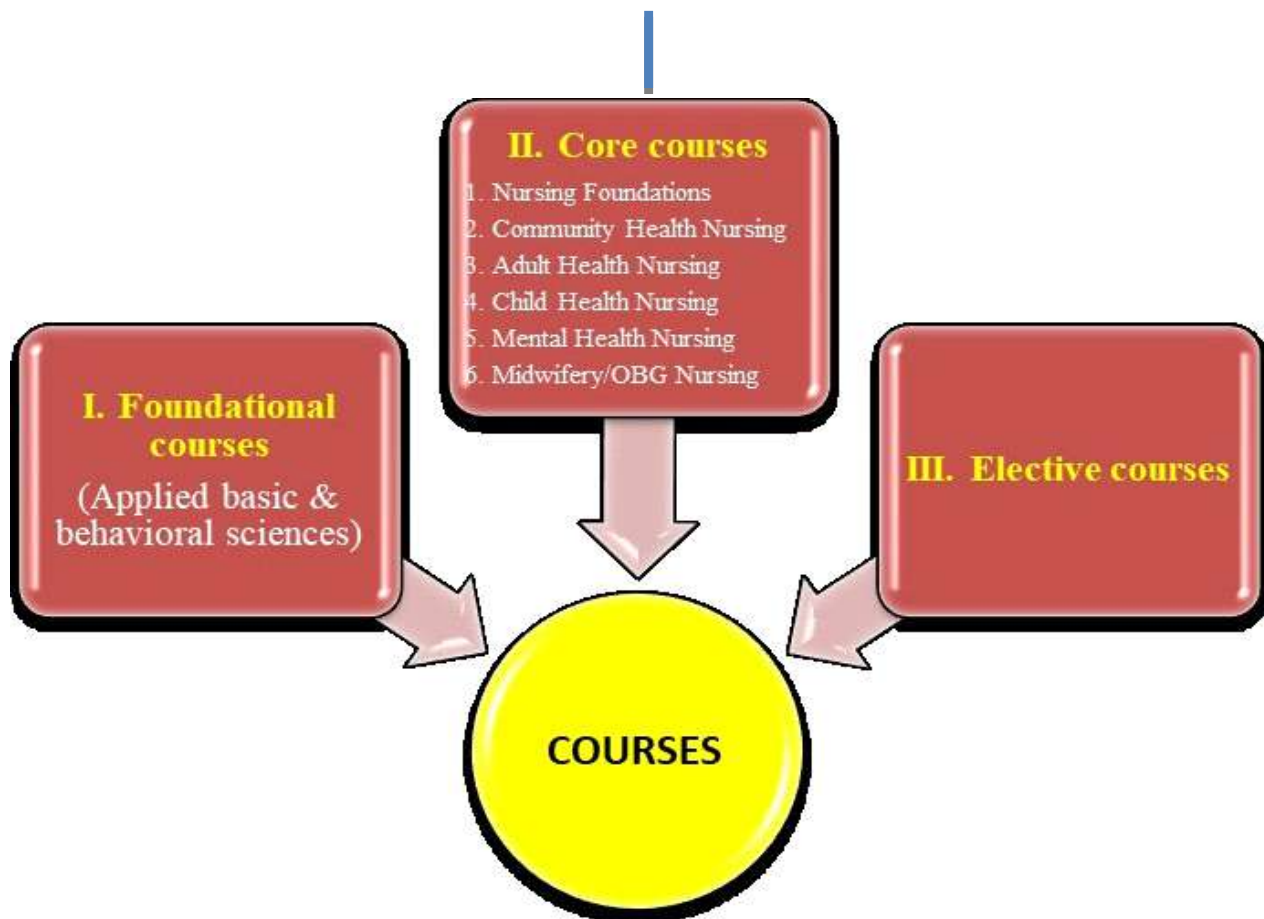
CURRICULUM

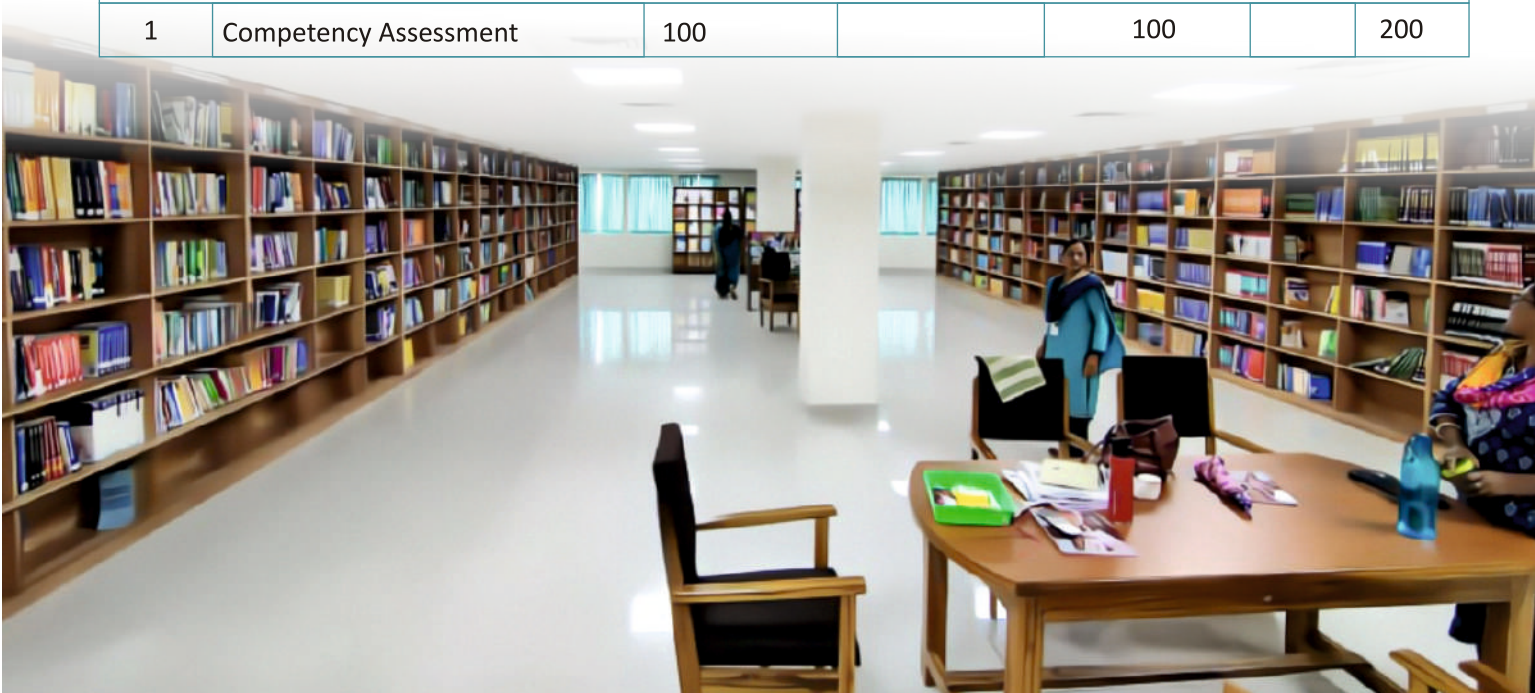

5.EXAMINATION REGULATIONS

Note:

1. Applied Anatomy and Applied Physiology: Question paper will consist of Section-A Applied Anatomy of 37 marks and Section-B Applied Physiology of 38 marks.
2. Applied Sociology and Applied Psychology: Question paper will consist of Section-A Applied Sociology of 37 marks and Section-B Applied Psychology of 38 marks.
3. Applied Microbiology and Infection Control including Safety: Question paper will consist of Section-A Applied Microbiology of 37 marks and Section-B Infection Control including Safety of 38 marks.
4. Applied Biochemistry and Applied Nutrition and Dietetics: Question paper will consist of Section-A Applied Biochemistry with 25 marks and Section-B Applied Nutrition and Dietetics with 50 marks.
5. Pharmacology, Genetics and Pathology: Question paper will consist of Section-A of Pharmacology with 38 marks, Section-B of Pathology with 25 marks and Genetics with 12 marks.
6. Nursing Research and Statistics: Nursing Research should be of 55 marks and Statistics of 20 marks.
7. A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each course/subject for appearing for examination.
8. A candidate must have 100% attendance in each of the practical areas before award of degree.
9. Following exams shall be conducted as College exams. The minimum pass is 50% except for Communicative English. The marks for all the college exams listed below alongside all other university exams must be sent to university for inclusion in the mark sheet and shall be considered for calculating aggregate and ranking for awards by university
 - i. Communicative English
 - ii. Health/Nursing Informatics and Technology
 - iii. Professionalism, Professional Values and Ethics including Bioethics
 - iv. Introduction to Forensic Nursing & Indian Laws

Award of rank will not be considered for those who fail in one or more courses and must have completed the program by 4 years. The mark sheet with grades and grade point average shall be given by the University for all courses. Communicative English and Elective Modules are not included for calculating Semester Grade Point Average (SGPA).

10. Minimum pass mark shall be 40% for Communicative English and in each of the Elective module. All Electives modules must be completed as indicated in specified semester and pass marks sent to university before appearing for final examination.
11. Minimum pass marks shall be 50% in each of the Theory and practical papers separately except in English.
12. The student has to pass in all mandatory modules placed within courses and the pass mark for each module is 50%
13. A candidate has to pass in theory and practical exam separately in each of the paper.
14. If a candidate fails in either theory or practical, he/she has to re-appear for both the papers (Theory and Practical).
15. If the student has failed in only one subject and has passed in all the other subjects of a particular semester and Grace marks of up to 5 marks to theory marks can be added for one course/subject only, provided that by such an addition the student passes the semester examination.
16. The candidate shall appear for exams in each semester:
 - i. The candidate shall have cleared all the previous examinations before appearing for the seventh semester examination. However, the candidates shall be permitted to attend consecutive semesters.
 - ii. The candidate shall have cleared all the previous examination before appearing for final year examination.
 - iii. The maximum period to complete the course successfully should not exceed 8 years.



17. The candidate has to pass separately in internal and external examination (shall be reflected in the marks sheet). No institution shall submit average internal marks of the students not more than 75% (i.e. if 40 students are admitted in a course the average score of the 40 students shall not exceed 75% of total internal marks).
18. At least 50% of the Non-nursing subjects like Applied Anatomy & Physiology, Applied Biochemistry, Applied Psychology & Sociology, Applied Microbiology, Pharmacology, Genetics, Nutrition & Dietetics, Communicative English and Health/Nursing Informatics & Technology should be taught by the Nursing teachers. Teachers who are involved in teaching non-nursing subjects can be the examiners for the program.
19. Maximum number of candidates for practical examination should not exceed 20 per day. Particular year and of same institution batch shall be examined by the same set of examiners
20. All practical examinations must be held in the respective clinical areas.
21. One internal and one external examiner should jointly conduct practical examination for each student.
22. An examiner for theory and practical/OSCE examination should be an Assistant Professor or above in a College of Nursing with M.Sc. (Nursing) in concerned subject and minimum 3 years of teaching experience. To be an examiner for Nursing Foundations course, the faculty having M.Sc. (Nursing) with any specialty shall be considered.
23. Examiner for Competency Assessment – VIII Semester: There must be a total of five examiners, one from each specialty i.e. External examiners – 2 and Internal examiners – 3. The internal examiners may be from the college faculty or from hospital with the required qualification and experience i.e. M.Sc. (Nursing) in respective specialty

At least 50% of the Non-nursing subjects like Applied Anatomy & Physiology, Applied Biochemistry, Applied Psychology & Sociology, Applied Microbiology, Pharmacology, Genetics, Nutrition & Dietetics, Communicative English and Health/Nursing Informatics & Technology should be taught by the Nursing teachers. Teachers who are involved in teaching non-nursing subjects can be the examiners for the program.
19. Maximum number of candidates for practical examination should not exceed 20 per day. Particular year and of same institution batch shall be examined by the same set of examiners
20. All practical examinations must be held in the respective clinical areas.
21. One internal and one external examiner should jointly conduct practical examination for each student.
22. An examiner for theory and practical/OSCE examination should be an Assistant Professor or above in a College of Nursing with M.Sc. (Nursing) in concerned subject and minimum 3 years of teaching experience. To be an examiner for Nursing Foundations course, the faculty having M.Sc. (Nursing) with any specialty shall be considered.
23. Examiner for Competency Assessment – VIII Semester: There must be a total of five examiners, one from each specialty i.e. External examiners – 2 and Internal examiners – 3. The internal examiners may be from the college faculty or from hospital with the required qualification and experience i.e. M.Sc. (Nursing) in respective specialty

COURSE COMMITTEE

1 The Course Committee consists of all faculty members assigned to the course to monitor the conduct and progress of the course in a semester. One faculty member will be assigned as the Coordinator. There will be one Course Committee for each set of courses being offered in a semester.

2 The Course Committee shall meet at least thrice in a regular semester: first at the beginning of the semester, second and third before the mid semester and end semester examinations respectively. After each meeting of the Course Committee members, the coordinator shall meet separately with the student representatives for confidential feedback.

3 The basic responsibilities of a Course Committee are to:

- i. Prepare a common course plan (lesson plan, course outcome, course objective, activity schedule, evaluation scheme, text and reference books etc.)
- ii. Review periodically the progress of the courses.
- iii. Discuss any issues concerning the conduct of the classes.
- iv. Decide distribution of the weight for tests, quizzes, assignments, laboratory work, etc. This should be done in the first Course Committee meeting.

4 For any difficulty related to a course, the student is expected to approach the respective course coordinator for advice and clarification.

5 The course coordinator will communicate the minutes of the Course Committee meetings, especially those of the first and second Course Committee meetings, to the Dean.

1. Minimum pass marks shall be 50 % in each of the Theory and practical papers separately.
2. A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination.

12. All practical examinations must be held in the respective clinical areas.
13. One internal and One external examiners(outside the University) should jointly conduct practical examination for each student
14. An examiner should be M.Sc (N) in concerned subject and have minimum of 3 (three) years post graduate teaching experience.
15. One internal and One external examiners(outside the University) should evaluate dissertation and jointly conduct viva-voce for each student
16. For Dissertation Internal examiner should be the guide and external examiner should be Nursing faculty / nursing expert in the same clinical speciality holding Ph.D./M.Phil/M.Sc. Nursing with a minimum of 3 years experience in guiding the research projects for Post Graduate students of Nursing.

Practicals

- 4 hours of practical examination per student.

Examination guidelines

1. Shall have one regular examination followed by a supplementary examination in a year.
2. If a candidate fails, they can be promoted to next year
3. A candidate can take any number of attempts, with the condition that the maximum period allowed is 6 years. However, all previous papers need to be cleared before appearing in the final examination
4. No institution shall submit student average internal marks more than 75% i.e., if 40 students are admitted in a course, then the average score of the 40 students shall not exceed 75%.
5. Example of 5 students: A=25, B=20, C=22, D=21, E=24. Average score=89.6% This will not be accepted by the State Nursing Registration Council
6. Minimum pass marks should be 50% in each of the Theory and practical papers separately.
7. Minimum pass marks shall be 40% for English only.
8. Theory and Practical exams for Introduction to Computer to be conducted as a School exam, and marks to be sent to the SNRC/ Board for inclusion in the mark sheet.
9. A candidate has to pass the theory and practical exams separately in each of the papers.
10. If a candidate fails in either the theory or practical paper, he/she has to reappear for both the papers (Theory and Practical)
11. All practical examinations must be held in the respective clinical areas.
12. One internal and one external examiner should jointly conduct the practical examination for each student.

Eligibility for Examination

A candidate shall be eligible for admission to the state Council / Board examination if the Principal of the school certifies that:

- a. She/he has completed not less than eleven months of the course
- b. A candidate must have a minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject to appear for the examination.
- c. The diploma shall not be awarded to the student till she/he has completed the clinical / field requirements.**
- d. A Candidate must secure 50% marks in the internal assessment separately in each theory and practical.
- e. The record of practical experience is complete.

(The principal shall send to the Council/board the internal assessment for each subject, i.e., both theory and practical (S), before the start of the examination, along with the examination form.)

Grading of Examination

Examination shall be graded on aggregate marks of the entire three years of the training programme, as follows:

Theory Examination

- A nursing teacher with a minimum of five years of teaching experience (recent) in a particular subject may be appointed as paper setters and examiners for that particular subject only.
- The question paper should have a combination of essay, short answer, and objective-type questions as detailed in the content
- All units of a subject and sub-subject should be given due weightage following the instructional hours prescribed.

Practical Examination

- Practical examination is to be conducted in the respective clinical area.
- A nursing teacher with a minimum of five years of teaching/clinical teaching experience in a particular subject /clinical area may be appointed as a practical examiner.



College Disciplinary Rules

1. If a candidate fails to join or leave the college after admission, the fees so paid shall not normally be refunded except where the candidates prove to the satisfaction of the Principal that failure to join the course was due to the reasons beyond his/her control.
2. All newly admitted students will have to deposit the tuition fee along with other charges within the dates prescribed in the letter of the admission issued by the Kalinga Institute of Industrial Technology /Principal, KINS.
3. All applications for leave must be made in writing to the Principal.
4. Every student is required to complete the percentages of attendance as prescribed by the INC and University.
5. Every student must maintain discipline & follow the rules & regulations in the College, Hospital & Hostel as well as in & around the campus, failing which the Principal/ Dean/Director reserves the right to expel him/her from the Institute or to make him/her to vacate the hostel if he/she is a hosteller.
6. Bringing or consuming liquor/intoxicants inside the college, hostels & hospital premises is considered offence.
7. Students must be properly dressed while attending the lectures.
8. Most of the decision/ notices advertisements are displayed on notice boards & announced through class co-ordinator.



The student should always keep the identity card with him/ her & show the same to the faculty/ staff members as & when demanded. He/ She should also take the ID card while going outside campus. Non compliance may lead to disciplinary action.

Students shall obey the instructions of the faculty members & shall always interact with them with due respect.

No student shall take part in any undesirable activity or involve himself/ herself in any political or other movements of any manner during the course of study. Violation of this rule will make the student liable to disciplinary action & even expulsion from the college hostel or both.

Each student should behave with other students respecting each other's feelings & creating congenial atmosphere to study & live together pleasantly. Any act purporting to give rise to groupism & leading to any undesirable behaviour is forbidden. The use of all cell phones by the undergraduate students within the campus is prohibited between 8 am & 5 pm while attending classes. Violation of the rule will be viewed very seriously & cell phones will be seized by the faculty member/ officers of the University on the spot & handed over to the Principal. College, Hospital & hotels are non smoking zones. Smoking in these areas is considered as offence.



Facilities

- Internationally acclaimed research personnel, including Nobel Laureates and experts, and Scientists from research organizations are invited for interactive sessions with faculty and students to guide them and to provide them with higher exposure to research activities.
- 24x7 Library facilities and High-Speed Internet connectivity available.
- Students & teachers exchange program with various universities internationally.
- Mediclaim facilities up to Rs. 30,000/- for each student.
- Language training programs of different national & international languages for students & faculty.
- Our faculties maintain a mentor-to-mentee ratio of 1:20 to sort out their academic and other problems.
- Students participate in various activities like health education programs, National and international conferences, workshops, flash mobs, nukkad, natak, rally, etc.

Classroom: There are 17 classrooms for 50 GNM, 90 B.Sc. (N) & 21 M.Sc. (N) students. The classrooms are designed as per international standards, and the teaching is imparted with the help of the most sophisticated teaching aids like LCD projectors.

Laboratories: KINS has its well-equipped Maternal & Child Health Skill Lab, Nutrition Lab, Nursing Foundation Lab, Community Lab, Pediatric Lab, Medical Surgical Lab, Computer Lab, A.V. Aids Lab with net connections.

Library & Study Centre: KINS, as a wing of Kalinga Institute of Industrial Technology, has access to a well-stocked central library, reference section & online web journal facilities. Besides, KINS' library has a stock of the latest editions of books by prominent authors and journals from Indian and International publishers aimed at keeping the students and the faculty abreast with the modern technology and progress made in the field of medical science.

The library is fully computerized with Wi-Fi connection. The students can access CINAHL, MEDLINE, etc. Adequate textbooks & journals in hard copies are catalogued. Further, the students are allowed to access the central library for reference & research work. There are 7500 books under various subjects of nursing importance, along with 46 national & international journals of Nursing Sciences.

Conference Hall: KINS has its own air-conditioned Conference Hall, well equipped with a light and sound system.

Hostel & Guest House: KINS has separate hostels for boys & girls with modern amenities to help the students concentrate on their studies. A guest house with air-conditioned rooms and other facilities is also available for the distinguished guests.

Sports: With one of the biggest in-campus indoor and outdoor stadiums, KIIT provides facilities for all indoor and outdoor games. The facility includes an air-conditioned billiards room. An International Standard multi-sports stadium has been built for outdoor games such as basketball, track & field, cricket, lawn tennis, hockey, etc. In addition, there are 16 sports complexes located in different campuses, each having a swimming pool and facilities for a wide range of indoor and outdoor games. The institute has appointed full-time professional coaches for the growth of students in sports.

Health Club: To keep both body and mind fit –to undertake the challenges of life, KIIT has made all provisions for its students through sports, games, fitness, recreation, gym, etc. KIIT houses a health club with state-of-the-art facilities at par with 5-star hotels.

Post Office, Bank & Railway Reservation Counter: An in-house computerized Post Office is functioning in the main campus of KIIT. Banks with twenty-four-hour ATM counters are also operational on the campus.

Transportation, Market, Cafeteria & Canteen: KIIT has its fleet of buses to cater to the transportation needs of its students, staff members & visiting guests. The canteen is good at serving delicious food on time. The menu includes Oriya, South Indian, Chinese, and continental dishes. The cafeteria inside the campus serves soft & hot drinks, snacks & ice creams. In addition to the canteen, there are 15 food courts specializing in cuisines from different parts of the world. KIIT is in the process of establishing a multistoried supermarket complex.

Health care: KINS students are provided with Medicare facilities at our Pradyumna Bal Memorial Hospital.

Community Training: Institution has its own Community Health Centre (UHTC) at Niladri Vihar, Bhubaneswar, and (RHTC) at Kalarabanka. Students are required to possess special skills in providing primary health care preventive services & promoting health services to the community.

ICT Facilities: KIIT University leads in ICT facilities with over 1700+1024 Mbps internet via NKN, Airtel, and BSNL, offering a fully Wi-Fi-enabled campus. Students access 3250+ desktops spread across 41 labs and receive free laptops to enhance learning. The campus has uninterrupted power supply and is secured with 3300+ CCTV cameras. KIIT uniquely implemented SAP in all schools for online results, semester registration, certificate downloads, and payments. Platforms like Zoom, Google Classroom, and Google Meet support remote learning during the pandemic. This robust infrastructure enhances academic and research experiences.

A Ragging Free Campus

Ragging means 'Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness to any other student, indulging in rowdy or undisciplined activities which causes or likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a absence of shame or embarrassment to adversely affect the physique or psyche of a fresher or a junior student.

"Ragging in all its forms is banned in this institution, including in its departments, constituent units, all its premises (academic, residential, sports, kiosks, cafeteria, and the like), whether located within the campus or outside, and in all means of transportation of students, whether public or private. The Institutions shall take strict action, including but not limited to criminal proceedings and or cancellation of admission, against those found guilty of ragging and/ or of abetting ragging, and the burden of proof shall be on the perpetrator of alleged ragging and not on the victim.

An offence of ragging may be charged either on a written complaint by the affected or on an independent finding of the Anti-Ragging Squad. The Institution is bound by the UGC Regulations on curbing the menace of ragging in Higher Educational Institutions 2009. "As per the Supreme Court of India order, May 2007, vide item no 33, Court no 4, section XIA, Anti-ragging committee and anti-ragging squad have been formed to implement the recommendations made by the Raghavan Committee to tackle the problem of ragging in the Institution. In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she has been indulging in ragging, admission may be refused or he/she shall be expelled from the Institution. Victims of ragging should immediately approach any faculty/ staff member and seek their intervention. Every single incident of ragging where the victim or his parent/ guardian or the Head of the Institution is not satisfied with the Institutional arrangement for action, a first information report shall be filed without exception by the Institutional authorities with the local police.

- Tutor Mentor will spend 4-5 days at the beginning of the session with the students attached to him/her and prepare a "Case Study" of the student, exploring all the possibilities, and give them tips about all the activities going on and around the KIIT.
- Every 2nd and 4th Saturday, there is a meeting held by the tutor mentors for the mentees.

Punishment for Ragging

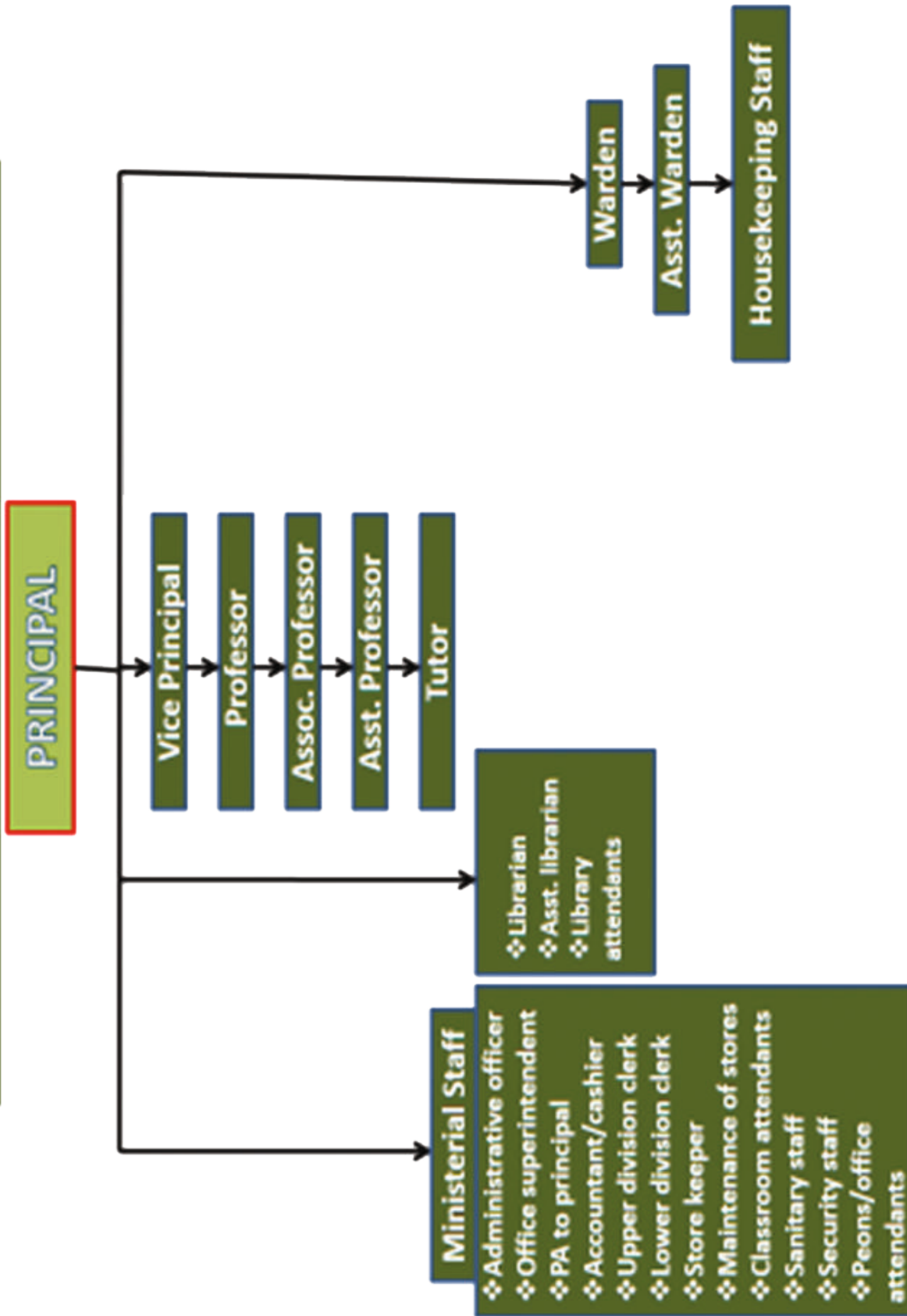
According to KIIT University, ragging is strictly prohibited and punishable with severe consequences based on the nature and gravity of the offense. The punishments include:

- Cancellation of admission
- Suspension from attending classes
- Withholding or withdrawal of scholarships, fee concessions, and other benefits
- Debarring from appearing in tests, examinations, or other evaluation processes
- Withholding of examination results
- Debarring from representing the institution in sports or other events
- Suspension or expulsion from the hostel
- Rustication from the institution
- Expulsion from the institution with debarment from admission to any other institution
- A fine of Rs. 30,000
- Referral to police for very serious or grievous offenses
- Collective punishment where offenders act as a group
- Criminal proceedings under applicable sections of the Indian Penal Code

The institution follows UGC Regulations (2009) and the Supreme Court directives, and the Anti-Ragging Committee's decisions are final and binding. The burden of proof lies on the accused, not the victim, and strict action, including criminal proceedings, may be taken.

Rules & Regulations of Central Library

Membership:

Eligibility:

- a) Faculty members
- b) Undergraduate students/ PG students
- c) Tutors

1. Every user of the Central Library must register his/ her name in the library. (Form for registration to be supplied by the library office).
2. All the users of the Central Library, except the eligible users, shall pay Rs. 2000/- (Rupees Two Thousand only) for individuals for three years, which is non-refundable, and they will not be issued any book out of the Library Reading Room. In this regard, the Librarian should provide adequate information to the surrounding institute.
3. Retired faculty members from this Institute are welcome to utilize the library facility inside the library.
4. Current awareness Service is to be provided in the library.
5. One book shall be issued to the users for a period of 15 days.
6. Members shall appear in person to take books on loan.
7. Circulation of informational documents will be provided daily to its users.
8. If a book or informational document is not returned by a borrower within 15 days of issue of the book/ informational document, a retention fee of Rs 5/- (Rupees Five only) per day up to a maximum limit of fifteen days shall be charged on the borrower. In case this informational document is not returned within that period, other disciplinary action would be taken against the borrower as deemed fit by the Chairman of the Library Committee.
9. When the due date for the return of the book falls on an authorized holiday, it may be returned on the day the library reopens.
10. A borrower against whom any overdue or other charge is outstanding shall not be allowed to borrow books from the library.
11. No book shall be issued to a borrower who has lost a title until such time the lost title is replaced or paid for.
12. A borrower shall be responsible for all books issued on his/her library card.
13. Handle the books and journals with care. Do not disfigure these documents by writing or making underlines in the pages, and do not tear out any page from the book. In this case, the full present cost will be charged.
14. If an informational document is lost by its borrower, then ten times the price of the said document will be collected from the borrower.
15. A student shall cease to be a member of the library if he/she ceases to be a student of the Institute.
16. Informational documents are not transferable.
17. Journals, magazines, Newspapers, and other reference materials are to be used strictly inside the Library Reading Room.
18. If any reader damages the furniture or removes or attempts to remove from the library, an informational document that has not been duly made over to him/ her by the library personnel, appropriate action shall be taken against him/her.



19. A list of recent arrivals of informational documents is to be noticed in the Reading Room Notice Board.
20. Suggestion for procuring the books: Suggestion slips are provided in the library.
21. The reservation facility for informational documents is provided in the library for the users.
22. Silence is the golden rule in the library. The use of cell phones and smoking is strictly prohibited in the library. All who happen to be inside the library are expected to observe strict silence and maintain discipline in the library.
23. The checking counter Attendant is authorized to examine everything that passes into or goes out of the library.
24. Every user shall be issued a library card affixed with his/her photograph.
25. Loss of a library card issued to a borrower must be reported to the Librarian immediately, and a duplicate card will be issued on payment of Rs. 50/- (Rupees Fifty Only)
26. Library cards are not transferable.
27. All readers should read the library rules. Ignorance of Library rules will be of no excuse.
28. Do not bring food or drink of any kind into the library.
29. Do not keep feet on the furniture or spill ink on the floor.
30. Sticks, umbrellas, handbags, and articles are prohibited inside the reading hall. These can be kept in the property counter. Library staff are not responsible for the loss of any personal belongings.
31. The staff who shall leave the college on proceedings to higher studies or training either inside the country or abroad/ retirement from the service, or otherwise, are to furnish the clearance certificate from the library before they are relieved.
32. All users who take books from the library shall return them before going on leave.
33. No book from the library shall under any circumstances be taken into the dissection room or the post-mortem room.
34. The readers should not reserve the seats in the reading hall. When they go out of the library, they should return the library books to the counter and take back their personal note along with them; otherwise, the library staff will not be responsible for the personal books and will remove the library books to the respective places.
35. Borrowers are advised, in their own interest, to inspect informational documents issued to them at the time of issue and to call attention to any damage or defacement detected by them. Any damage or mutilation of a book noticed at the time of returning shall be described to the borrower.
36. Xerox facilities are to be provided free for faculty members for academic activities with the recommendation of the HOD. For personal use, they have to pay fifty paise per page for the users (staff and students).
37. A sum of Rs. 5000/- (Rupees Five Thousand Only) shall be placed at the hands of the Librarian towards emergent and incurring miscellaneous expenditure.
38. There shall be a stock taking of the library under the guidance of the Librarian.
39. The Library Committee has to frame additional rules and regulations with the approval of the principal, as may be necessary from time to time, for smooth management of the library.
40. A copy of the Central Rules and Regulations shall be made available in the Reading Room Notice Board and Library Board.



Rules and Regulation

- o **Disciplinary committee of KINS has formulated general guidelines applicable to GNM, B.Sc.(N) & M.Sc.(N) students for smooth management & timely completion of their requirements with immediate effect. The rules are as follows:**
- o Half-yearly attendance percentage and examination marks to be sent to parents of each student through email, and will be verified by a telephonic conversation with the mentors.
- o The GNM, B.Sc. (N) & M.Sc. (N) students' makeup duties will be counted in days or in hours. The students have to compensate for makeup duties & it will start after completion of the course.
- o Absence in class and clinical without prior permission /without any valid reason will be treated with a Rs. 500/-fine separately.
- o Students caught using mobile phones in class/clinical will be punished with a Rs. 1000/-fine.
- o Before the commencement of the model exams, all students must complete and submit their clinical requirements to their respective subject teachers and have them signed, or else, they will not be allowed to write the model exam.
- o Submission and publication of the dissertation (Thesis) in an indexed journal for M.Sc. (N) 2nd year is mandatory one week before filling out the form for annual examination as per University guidelines.
- o Harassment to fellow boarders and misbehavior of any form Rs.5000/- of fine will be imposed on students.
- o Misbehavior toward any faculty in college will result in a Rs. 2000/- fine being imposed on students.
- o Ragging is prohibited; if it's done by any student, appropriate action will be taken against him /her as per the rules laid down by the Indian Nursing Council.
- o Intentional damage to any college property: Rs 5000/- fine for the person.
- o Forging the signature of the faculty or any staff of the hospital by the students in any document, a Rs. 5000/- fine will be imposed on him/her.
- o A candidate must have a minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each course /subject for appearing in the examination as per the Indian Nursing Council
- o A student, who has been absent for short periods of time from lecture classes due to participation in the cultural event(s), sports, NCC, NSS or any other academic or official assignment(s) in the interest of KIIT – DU with the prior written permission of the Principal of the School or on any health ground duly supported by the medical certificates or any extraneous situations like mishap in the family or any other genuine reasons, may be permitted for a maximum concession of 10% in the attendance and would be eligible for appearing in the end semester/year examination of a theory subject with an attendance not less than 70% for that subject in the semester/ year. This relaxation in the attendance can be considered by the Principal of the School on a case-by-case basis as per the university guideline.
- o Any deviation in abiding by the rules & regulations related to the curriculum will impose a fine of Rs. 1000/- on the student.
- o If PG students will not attend the clinical experience outside the state, then she/he will be imposed a Rs. 5000/- fine and compensated for the said days by doing double make-up duty.
- o If any student is found with any items related to malpractice during the exam/they will be liable for appropriate action as per the University rule.



HOSTEL RULES AND REGULATIONS

1. Conditions of Allotment

- 01.1 At the time of admission of the boarder into the hostel and at the beginning of every year, each boarder is required to submit Personal Information Form duly completed in all aspects. The telephone number of the parent with STD code must be provided along with Local Guardian's address and phone number. Email of the parent (if available) should also be provided. Any change of address / telephone number of the parent / local guardian, at any point of time, has to be intimated to the hostel office in writing.
- 01.2 In general, minimum furniture and fittings for each room will be provided consisting of one each of cot, mattress, bed sheet, blanket, pillow, table, chair etc.
- 01.3 Rooms once allotted to the boarders for an academic year will not be changed except on special situations.
- 01.4 The authority, if in case of non-availability of rooms, can allot more boarders per room for a temporary duration.
- 01.5 The boarders are entitled for accommodation in the hostel as long as they are full time registered students. Accommodation will not be provided to any boarder whose registration is cancelled. Any boarder who is removed from the rolls of the University will automatically cease to be a member of the hostel.
- 01.6 Before vacating the rooms, the boarders should fill up the sign the furniture & fittings register. The electrical installations and fittings should be handed over intact, in addition to the furniture.
- 01.7 Authority reserves the right to order to break open rooms in case of any violation of hostel rules, suspected unlawful activities or on the basis of security risk perceived.
- 01.8 Once a boarder vacates the hostel or forfeits the allotted accommodation he/she will not be re-allotted hostel accommodation for a minimum period of 6 months.
- 01.9 The Chief Warden / Deputy Registrar/ Sr. Administrative Officer / Superintendent or respective hostel personnel of KIIT can enter any room for verification at any time of the day or night.
- 1.10 Student who failed to maintain required attendance for consecutive semesters, would be not allowed hostel accommodation for consequent year.

2. Tenure of Occupancy

- 02.1 Initially, during first year of admission the boarder will be provided with hostel accommodation ordinarily for a period of one year. There after they may be shifted to different hostels depending on their program of study.
- 02.2 Boarders shall occupy the hostels allotted to them till the day following their final professional examination of the last academic year.
- 02.3 Boarders are not allowed to retain possession of the hostel room under their occupation or lock up their luggage in their rooms during the vacation or during the summer project period.

3. Termination of Residency

- 03.1 De- allotment of any hostel boarder in middle of the academic year is not allowed.
- 03.2 The authority can end this residency at any time if: (a) the boarder fails to pay any sums due to the hostel within fifteen days of the due date (b) if the boarder fails to comply with the terms of residency.
- 03.3 Admission and stay in the hostel cannot be claimed as a matter of right.

4. Leave System

- i. Hostel leave ordinarily shall not be allowed to any boarder except for weekend visit to home / local guardian with prior permission. However, in case of emergency leave can be considered with permission of the Principal/ Administrative Officer / Warden. For long duration leave (exceeding 2 days) prior permission of the Faculty Adviser/Tutor-mentor and Principal /Sr. Administrative Officer is required.
- ii. The application for leave should reach the hostel office on the preceding day. In case the date prior to the date of leave is Sunday/holiday, the date of application should be previous working day.



4.1 Sick Leave

- i. In case of illness, a boarder can avail leave with permission from the Principal / Sr. Administrative Officer of the respective hostels.
- ii. On joining the boarder has to produce a medical fitness certificate in the School and hostel

4.2 Personal Tragedy

- i. In case of personal tragedy, a boarder can avail leave with permission from the Principal / Administrative Officer of the respective hostel.

4.3 Academic Requirement

- i. For any academic requirement or requirement of the University if a boarder has to remain on leave he/she has to take necessary permission and apply for leave from hostel to the Principal / Administrative Officer.

4.4 Important Family Function

- i. A boarder may avail leave to attend to important family functions held for immediate family members. She / He has to take necessary permission and submit the leave form to the Deputy Registrar / Administrative Officer of the respective hostels

5. Daily Attendance

- 5.1 Boarders while going out of the hostel have to register in "OUT" biometric machine & when coming back to the hostel have to register in "IN" biometric machine.
- 5.2 It is mandatory for the boarders to register their attendance in the biometrics machine during 7.30 PM to 9.30PM everyday.
- 5.3 During Sundays, Holidays and after the class on regular days, boarders are required to register their exit in "OUT" biometrics machine whenever they are going outside of the hostel.
- 5.4 When boarders are taking leave from the hostel they have to register their exit in "OUT" biometrics machine along with submission of hostel leave form.
- 5.5 Boarders who will not register their attendance between 7.30PM to 9.30 PM in the biometrics machine will be put up in the notice board and action deemed fit will be taken. Boarders who want to use reading room during night time have to register the exit in "OUT" biometric machine & take "READING ROOM PASS" & follow the procedure as defined. Any authorized absence from the hostel shall be viewed seriously and disciplinary action as deemed fit shall be taken. As 1st step, a boarder who leaves the hostel without prior permission may be denied entry back to the hostel.

6. Code of Conduct of Boarders

- 6.1 All boarders are required to maintain standards of behaviour expected out of boarders of a prestigious University such as ours. They are expected to behave courteously and fairly with everyone both inside and outside the campus.
- 6.2 All boarders are required to carry their valid identity cards issued to them.
- 6.3 The rooms, common areas and surroundings should be kept clean and hygienic. Notices or posters shall not be pasted on walls and walls shall not be scribbled on.
- 6.4 The return time to the hostels will be notified by the Deputy Registrar/ Administrative Officer at the beginning of the Academic year.
- 6.5 All the boarders are expected to be in the hostel before the expiry of the entry time notified. If any boarder wishes to be away from the hostel during the weekend, holidays or any other time, he/he has to take prior permission



- 6.6 Room allotted to the boarder is on his/her personal responsibility. He/ She should see the unkeep of his/her room, hostel and its environment. Boarders should bring to the notice of the AO for all routine maintenance works (Civil, Carpentry and Electrical), if any, to be carried out in their rooms.
- 6.7 Boarders should cooperate in carrying out maintenance work and vacate their rooms completely when the authority requires the rooms for this purpose. On such occasions, the management will try to provide alternate accommodation. If any maintenance work is to be carried out when the room is under occupation, it is the occupant's responsibility to make the room available for the same.
- 6.8 The boarders should not screen movies in their computer & common rooms.
- 6.9 The boarders of the room is responsible for any damage to the property in the room during his/her occupancy of that room and will be required to make good the damage, if any. He/she is required to fill in the inventory of the furniture and other items available and hand over the furniture & other materials in good condition when he/she changes/vacates the room/hostel.
- 6.10 In case of damage to or loss of hostel property the cost will be recovered from the boarders responsible for such damage or loss, if identified, or from all the boarders of the hostel, as decided by the authority.
- 6.11 The resident shall not move any furniture from its proper allotted place and also not damage them in anyway. If there are any additional items other than the above belonging to the hostel in a room, the occupant of the room shall hand over them to the AO, failing which he/she will be charged a penal rent as decided by the Authority. The resident shall not move any furniture from its proper allotted place and also not damage them in anyway. If there are any additional items other than the above belonging to the hostel in a room, the occupant of the room shall handover them to the AO, failing which he/she will be charged a penal rent as decided by the Authority.
- 6.12 Ragging and harassment in any form of boarders admitted to the University is totally banned. Any violation of this by the boarders will be dealt with very severely.
- 6.13 All boarders are encouraged to report incidents of ragging if they happen to see such thing. Those who do not do so even when being witnesses or victims, can also be punished suitably.
- 6.14 When the persons committing or abetting the crime of ragging are not identified, collective punishment could be resorted to as a possible deterrent measure, as it would ensure community pressure on the potential raggers not to indulge in ragging.
- 6.15 All boarders are required to furnish Anti-ragging Affidavit (both the boarder and parents) (Annexure-II & III).
- 6.16 Smoking & consumption of alcoholic drinks and/ or narcotic drugs in the hostel premises is strictly prohibited. Boarders shall not enter the hostel premises in intoxicated state and should not possess any such materials. Several action will be taken if any boarder is found to violate this, resulting in expulsion from hostels and rustication from the University. Depending on the case, the management reserves the right to take direct disciplinary action, amounting to even expulsion at short notice from the hostel.
- 6.17 Employing unauthorized persons for personal work such as washing clothes, etc, is not permitted. Members of the mess staff should not be asked to enter the boarders residence area on any account.
- 6.18 Boarders from one hostel are not permitted to enter into other hostels.
- 6.19 Any boarder found/hosting/ harbouring an offender will be also liable to the disciplinary action.
- 6.20 Boarders cannot participate in any anti-national, antisocial or undesirable activity in or outside the campus.
- 6.21 The visit of a person of the opposite sex to the hostel is restricted.
- 6.22 Parties, birthday celebration, social or political gatherings in the hostel complex are completely banned inside the hostel.
- 6.23 The boarders will be allowed to stay out of the hostel on submission of proper application duly authorized by the parent and only if the permission granted in writing by the Principal.



- 6.24A hostel campus should be place where boarders can have the best possible conditions for studying and adequate rest. Noise level must be kept low to allow other's the opportunity to study or sleep in comfort. Television Radio etc provided in the common room must be switched off or volume toned down after 10.00am.
- 6.25In case of any unacceptable behaviour by the room-mate, the other room – mate must report it to the hostel authorities.
- 6.26Boarders are responsible for keeping their rooms and the common areas in the hostel such as visitor's area, bathrooms, stair case, and common room etc clean and tidy at all times.
- 6.27All fans, lights and electrical appliances must be switched off when not in use.
- 6.28Pets are not allowed in the hostel complex.
- 6.29Non boarders are prohibited in the hostel without the permission of the Principal/ Administrative Officer/Warden. The boarder who encourages this is liable for disciplinary action.
- 6.30All instructions/ notices displayed on hostel notice boards or in the e-help desk will be deemed to have been read by all boarders and excuses for non- compliance of such instructions and notices will not be accepted. Boarders are advised to look at the notice board.
- 6.31Boarders must register their movement in the biometrics system maintained in the hostel reception while they are entering into or going out of the hostel.
- 6.32Water is an essential but scarce commodity. All boarders should use water judiciously and preserve it. Leakage etc. in the bathrooms should be immediately reported in the reception.
- 6.33The boarders must give adequate attention to the studies. Study our will be maintained in the hostel in which no boarder is allowed to visit others room or interfere in their studies. Administrative Officer from time to time. Complaints from other boarders will be investigated and severe disciplinary action will be taken.
- 6.34When the boarders go out, they should plan to return to the campus before the stipulated time.
- 6.35Boarders should avoid visiting hotels in the city, especially at night.
- 6.36Boarders are not allowed to involve themselves in any betting or gambling either inside or outside the hostel. This will invite stringent disciplinary action.
- 6.37The boarders shall not indulge in any act of theft, immoral acts, misbehaviour, spread of regionalism, communalism and casteism stc.
- 6.38The boarders are not allowed to play outdoor games other than those allowed by the Deputy Registrar/ Administrative Officer in the hostel premises.
- 6.39Playing of colors or bursting of crackers inside the hostel is banned. This will invite severe disciplinary action.
- 6.40Visit to places like sea beaches, water fall area, reservoir area, tanks and ponds etc. Where there is potential danger to the life and security of the boarder is banned.
- 6.41The boarders shall observe 10.00pm to 6.00 am in silence hours.
- 6.42Every information about every boarder will be intimated to their respective parents and guardians.
- 6.43Marketing/ sales of any kind of product is not allowed inside the hostel complex, however prior permission ha to be taken from Dy. Registrar.
- 6.44Prior permission has to be taken for putting up posters/banners inside the hostel complex from Dy. Registrar/Administrative Officer/Warden.
- 6.45Boarder entering inside other hostel and creating nuisances/ disturbance/ manhandling/ physical assault at any form will attract disciplinary action and monetary fine will imposed upon fellow boarder or group of boarders.
- 6.46Use of Dendrite and Eraz-ex is not allowed inside hostel however other kind of adhesive (;Fevicol, Fevistick etc) is allowed.
- 6.47Outside orders (; Foods/or any other parcel orders) will not be allowed inside the hostel after 8.00pm.



7. Security & Safety

- 7.1 Boarders are required to carry their I-Card at all times in the compound of the hostel complex and produce it on demand by the authorities.
- 7.2 Boarders are advised to lock doors when they leave the room for security reason.
- 7.3 The authority is not responsible for any loss of private property. Boarders are strongly advised to lock all their valuable e.g mobile phones/laptop, watches, money etc at all times.
- 7.4 Boarders are not permitted to change rooms or sleep anywhere other than in their designated room.
- 7.5 The boarders are advised not to keep large amount of cash or valuables in the room. The boarder is responsible for the safety of his/her belongings inside the room.
- 7.6 All boarders must take care of their ATM/ Debit/ Credit cards. They must not disclose their PIN to anybody-even to their best friends.
- 7.7 Any boarder who finds his/her roommate missing for more than 24 hours must report to the Dy. Registrar/ Administrative Officer/ Warden immediately. This is to enable the hostel authorities to take immediate action.
- 7.8 Possessions, distribution and use of fire-arms, lethal weapons including air gun, contraband drugs, alcohol, toxic and hazardous material are strictly prohibited in the hostel.
- 7.9 Any case of theft should be reported promptly to the Dy. Registrar/Administrative Officer/Warden.
- 7.10 In case of fire, boarders must raise an alarm and alert the hostel staff immediately.
- 7.11 Hostel rooms can be checked by any hostel staff at any point of time.
- 7.12 No boarders or group of boarders are allowed to go to the terrace of hostel complex for any reason.

8. Guests

- 8.1 Boarders entertaining unauthorized guests will lead to severe punishment including expulsion from the hostel.
- 8.2 Authorized guests are not permitted in a boarder's room rather they can interact in the hostel reception area.

9. Visitors

- 9.1 All visitors to the hostel including the parents/guardians will have to make necessary entries in the visitor's book available at the hostel entrance with the reception.
- 9.2 Visitor/ Parents / Guardians can meet their ward in the reception area of the hostel. However, they are not allowed to visit their ward inside the respective rooms.

10. Use of Appliances

- 10.1 The use of electrical appliances such as immersion heaters, electric stove/heaters/ electric iron/ cooler/ Refrigerator are forbidden in any of the rooms allotted for residence. Private cooking in the hostels/boarder's room is strictly forbidden. Such appliances, if found will be confiscated and a fine will also be imposed.
- 10.2 The use of audio systems which may cause inconvenience to other boarder is not allowed.
- 10.3 When the boarders go out of their room they should switch off all the electrical/ electronic appliances, and keep it locked (at all times). Violation will attract suitable penalty and punishment as decided by authorities.

11. Collective Responsibilities

- 11.1 General damage to the hostel property will be the collective responsibility of all the boarders and they will be required to make good such damage, if the boarders who caused the damage could not be identified.
- 11.2 Boarders should not indulge in practices/activities, which may endanger their own personal safety as well as others.
- 11.3 Boarders are duty bound to report to the Hostel Authority in case they notice any untoward incident undesirable activity going on in the hostel or on the campus by the fellow boarders.



- 11.1 General damage to the hostel property will be the collective responsibility of all the boarders and they will be required to make good such damage, if the boarders who caused the damage could not be identified.
- 11.2 Boarders should not indulge in practices/activities, which may endanger their own personal safety as well as others.
- 11.3 Boarders are duty bound to report to the Hostel Authority in case they notice any untoward incident undesirable activity going on in the hostel or on the campus by the fellow boarders.
- 11.4 Use/keeping of motor vehicles by boarders is completely banned. Boarders violating this ban are liable for punishment. Motor vehicles brought to the campus will be seized and hostel accommodation will be cancelled.
- 11.5 Boarders should not arrange any functions or meeting within the hostel or outside or within the University campus without specific permission of the concerned authorities.
- 11.6 Boarders cannot arrange/ for any picnic without specific written permission of the Principal/Dy. Registrar.
- 11.7 Boarders are required to be conscious of the environment in which they live by keeping it clean, healthy and presentable. Boarders should not throw litter indiscriminately and should not use non-bi-degradable items, such as carry bags.
- 11.8 The jurisdiction of KIIT Deemed to be University is confined to the Academic and Hostel campus. If boarder create law and order problems outside the campus, they are answerable to the police.
- 11.9 Picking up a quarrel with the auto/ bus crew will only land them in trouble.
- 11.10 Boarders are advised not to go out in large groups which are difficult to control. If any boarder get involved in unpleasant situations, he/she is not the only one to be affected but the whole group will be affected but the whole group will be affected. Which will end up creating a bad impression of the University.
- 11.11 KIIT Deemed to be University will do its utmost to protect you as long as you are on the right side of the law. Do not overstep your limits.

12. Mess Rules

- 12.1 No boarder is allowed to stay in the hostel without being a member of the mess.
- 12.2 Once a boarder reports in the hostel he/she deemed to have become a permanent member of that mess throughout the allotment period. No change of mess is allowed.
- 12.3 Boarders who absent themselves on the date of reopening of the academic session will be deemed to have joined the mess.
- 12.4 The mess timings are as follows and the boarders should strictly adhere to these timings: Breakfast-7.30-10.00am, Lunch-12.00-2.00pm, Dinner- 8.00-10.00pm.
- 12.5 Ordinarily the menu and quantity of food will be pre decided and will be served accordingly. In emergencies there can be little variation to the menu pre decided.
- 12.6 In case of sudden illness, special food can be provided on prior intimation.
- 12.7 Boarders are not permitted to enter the kitchen or store room of the mess on any account.
- 12.8 Boarders are not permitted to cook any food on their own accord in the messes or in their rooms.
- 12.9 Boarders on no account whatsoever will be permitted to take food outside the Dining Hall. Nor can they take mess utensils such as plate, spoon, tumblers, etc to their rooms.
- 12.10 No food will be served in the rooms of the hostel for any boarder unless it is felt necessary by the AO of the hostel that the boarder's condition requires the food to be served in their rooms.
- 12.11 No boarder should waste food. Paying mess bill does not entitle a boarder to waste food.
- 12.12 Boarders should assist a maintaining the mess and surroundings neat and clean. No notices shall be pasted on walls. Notices put up on notice boards by the Hostel Authority should not be removed by the diners.
- 12.13 All diners shall interact with the mess staff in the dining hall in a courteous manner.

- 12.14 If any diner is medically ill and requires a special diet he/she can request to arrange for the same at the mess.
- 12.15 No complaint will be entertained regarding refund of mess dues in case of a boarder fails to take food in the hostels.
- 12.16 Boarders are not allowed inside the Canteen if they are wearing vest and short pants. Proper home dress code to be maintained.

13. Special Provisions for Foreign Students

- 13.1 All the rules and regulations given above are applicable to the Foreign Students as well. In addition, the following special rules are meant exclusively for foreign students.
- 13.2 If any student wants to leave the country on vacation or for any other purpose the individual will submit a written application at least 15 days prior to the date of departure to the Principal to enable the office to obtain all the required clearances from the authorities concerned.
- 13.3 The application should have details such as (i) purpose, (ii) duration of stay outside India, (iii) full contact address with phone number.
- 13.4 The boarders must inform the hostel authority about their movement if he/she is going beyond the hostel or academic campus area. For such visit they have to take permission of the hostel authority.
- 13.5 The boarders should not visit the area / places where they are not permitted according to the Visa provision

14. Girls' Hostel Specific Rules

In addition to general discipline rules, the boarders of Girls Hostel shall abide by the following rules;

- 14.1 Boarders leaving the hostel while going home on holidays, vacation, or on special purpose must produce the consent letter of their parents (fax message) and make proper entry in leave register, submit hostel leave form along with approval of the concerned authorities.
- 14.2 Boarders while coming back from their residence after availing leave, they should obtain one letter from the Guardian/Father/Local Guardian stating the time and date of their arrival at home and the time and date they left their home for the hostel.
- 14.3 No guests, including parents are allowed after the hostel timings in the hostel.
- 14.4 Only guests / visitors authorized by the parents are allowed to meet the boarder during the visiting hour.
- 14.5 The visitors / guest can meet the boarder in the reception area of the hostel during the visiting hours only.
- 14.6 The return timing to the hostel will be ordinarily as follows:
M.Sc students
B.Sc students (Except 1st year) : 7.30pm
- 14.7 Attendance of the boarders will be taken between 7.30pm to 8.30pm. During this they are required to remain present in their respective rooms.
- 14.8 Along with biometric attendance system, registers will be maintained for outside visit of the boarders on any day for any purpose.
- 14.9 In weekend/Holidays boarders are allowed to go out only for a duration of 4 hours at a stretch. Exceeding 4 hours, parents consent & approval of the hostel authority is required.
- 14.10 Normally, boarders will not be allowed to leave hostel for Airport/Railway station/Bus stand from 9.00pm to 5.00am. Hence, all are required to book tickets accordingly.
- 14.11 Boarders should hand over their room key in the reception before leaving the hostel during vacation positively.
- 14.12 Outside orders (i.e: food/ or any other parcel orders) will not be allowed inside the hostel after 8.00pm.
- 14.13 The visitors mentioned in the list submitted by the parents of the boarder will be allowed to visit only on Sundays between 9.00am to 5.30pm. Others are not allowed except with specific written request from the parents.
- 14.14 A boarder is allowed twice in a month to visit her local guardian's house. The AO/Warden's Girls Hostel is not responsible in case of any type of accident or hazard occurring to the boarders inside or outside the hostel.

15. Rights of the Authority

- 15.1 Any breach of these rules by the boarders will invite an enquiry / action that will be conducted by the appropriate authority.
- 15.2 If situation so warrants, the boarders can be suspended from the hostel varying from short to long duration as a prima-facie action pending enquiry. This will be notified by the Deputy Registrar / Sr. Administrative Officer/ Warden.
- 15.3 While conducting the final enquiry it will be ensured that opportunity is given to the boarder to present his viewpoint.
- 15.4 If the boarder is found guilty, then the appropriate authority will take disciplinary action deem fit. Depending on the case, the authority reserves the right to take direct disciplinary action, amounting to even expulsion at short notice from the hostel.
- 15.5 Notification of all disciplinary action will be made by the Deputy Registrar/Warden.
- 15.6 The authority reserves its right to change these rules from time to time keeping the boarders informed through general circulars displayed on the hostel notice boards or through the e-helpdesk of hostel.
- 15.7 The boarder must vacate the hostel on emergent ground within 12 hours of notice
- 15.8 Sample Disciplinary actions are given below. However, the Disciplinary Committee / Chief Warden reserves the right to propose other disciplinary measure deem fit.
 - i) Issue of written/verbal warning
 - ii) Place on conduct probation
 - iii) Ask to tender verbal/written public apology
 - iv) Ask to call his/her parents submit undertaking by the parents
 - v) He / she will be suspended from the hostel temporarily or permanently
 - vi) Record of his / her misconduct will be made in the personal file (Annexure-VI) and intimated to the School /Parent
 - vii) The cost of damage will be fully recovered from him / her together with penalty.
 - viii) He / she will also be fined commensurate with the offence committed (Annexure IV) or decided by the committee
 - ix) In case the Inter Hostel dispute/ contents a committee headed by chef wander will take appropriate actions other anyway
 - x) No recommendations will be given to him / her for higher studies

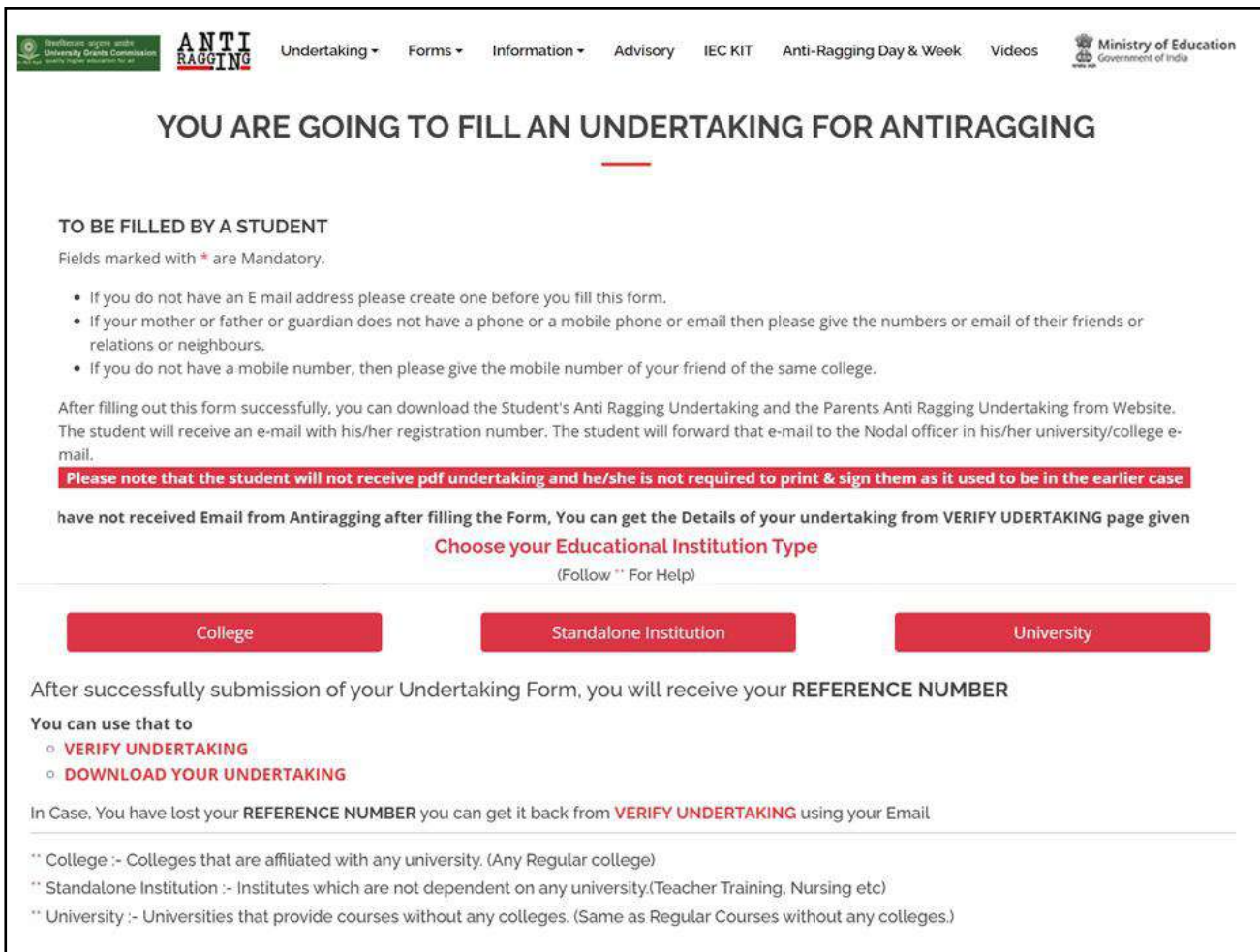

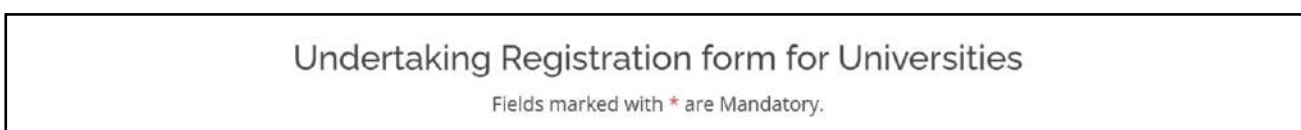

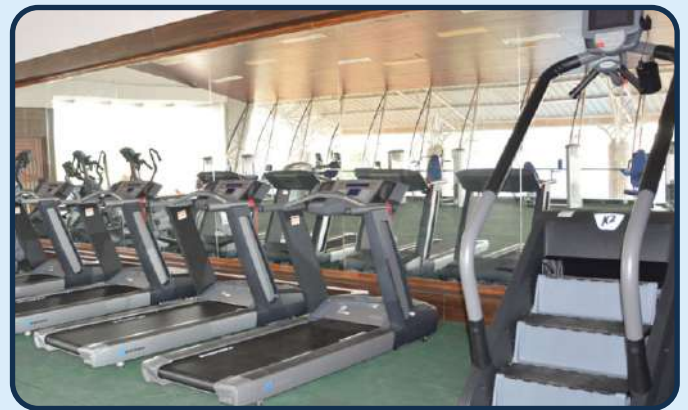
